

# LEGISLATION

*Report*


Four of our Buffalo/Erie Chapter members made the wet ride out to Albany for the ABATE of NY Freedom Rally on Monday, May 19th, and I had some great meetings there with Assemblyman Patrick Chludzinski and Senator Patrick Gallivan. Both legislators were former police officers, and both had great feedback for us with regard to the bills on our position paper.

Chludzinski, who was with the Cheektowaga Police Department's motorcycle unit, commented about the motorcycle crashes that he commonly responded to each and every year at this early point in the riding season. He said they would be either caused by an allegedly unseeing negligent driver or involve a single vehicle with an out-of-control rider. He went on to say that the second type would occur in the same places each year, and then he thought out loud about putting temporary signage up in common motorcycle danger areas, which I told him I thought was a great idea. Assembly Member Chludzinski is also on the Transportation Committee, so I will follow up with him about his idea and our bills again this summer when he's back in town.

Some may remember that Senator Gallivan's Chief of Staff spoke to us at our Seminar in January about the Grieving Families Act, which he sponsored in the previous legislative session, and now again with S2443. That Seminar was also when he was recruited into ABATE of NY by Sue Texido, our chapter's Membership Chair. We also know the Senator in Buffalo as our former Erie County Sheriff, and we have always enjoyed their support for our annual Awareness Run and our Red, White, and Blue C.O.P.S run.

During our meeting, Senator Gallivan said he'd consider sponsoring one or both of our reckless driving bills and asked me if profiling is still a challenge for motorcycle riders. When I told him about my experience being stopped by State Troopers while crossing the border into Canada for a motorcycle event a few years ago. Everyone on motorcycles was told to pull over for an inspection by the NY State Troopers, and they put a microphone next to my pipes and told me to roll on the throttle. I was then told it was over the 90 dB limit, but I was courteous and respectful and had no outstanding warrants, etc, so I was allowed to cross into Canada. This prompted Senator Gallivan to walk across the room and retrieve a new pamphlet that he was clearly excited about. It was an educational trifold on the topic of what to do when you're pulled over, which, I told him, seems like a very important topic in 2025. I will follow up with him in his office this summer about our legislation.

Finally, I'd like to recognize Lyle Bacon for also having two great meetings in the Legislative Office Building during our Freedom Rally. Like me, he had a couple of very positive and supportive conversations with his Chapter's legislators, and will be following up with them in the summer when they are back in their district offices. Due to some schedule shuffling caused by "emergency" meetings in the Assembly, Lyle was also able to score some Italian food in the atrium, and I'm more than a little jealous of that. Great job, man!

Additionally, the AMA supports the prominent placement of signage that notifies roadway users that the state provides specific sanctions for those convicted of moving violations while operating a motor vehicle in a distracted or inattentive manner. The inclusion of these sanctions depends on a state's current penalty structure of similar-magnitude offenses. All road users are responsible for the safe operation of their vehicles on public roads and highways. Advances in mobile technology have made it easier than ever to become momentarily distracted by operating the controls of a stereo system, a global positioning unit, or some other device.

The AMA supports legislation that includes enhanced penalty options against distracted driving. ## Shared Responsibility

The American Motorcyclist Association acknowledges that motorcyclists—in addition to car drivers, truck drivers, and even bicyclists—share this responsibility. Distracted motorcycle operation can be every bit as dangerous to the operator, other road users, and pedestrians as the distracted operation of a larger motor vehicle.

The AMA recognizes that distracted or inattentive driving has become a major concern to the motorcycling community. Far too many cases have been documented of motorcyclists being injured or killed as the result of other vehicle operators being distracted or inattentive.

Motor vehicle operators engaged in distracted or inattentive driving behaviors are not just a danger to motorcyclists – they endanger pedestrians, bicyclists, roadside assistance and emergency medical personnel, highway construction workers, law enforcement personnel, and the list goes on. For too long, inappropriate non-driving activities while operating a motor vehicle have been accepted as “just the way it is.”

Even the National Highway Traffic Safety Administration acknowledges that distracted and inattentive driving behaviors have significantly contributed to motor vehicle crashes. From an NHTSA report:

“Driver inattention is the leading factor in most crashes and near-crashes, according to a landmark research report released today by the National Highway Traffic Safety Administration (NHTSA) and the Virginia Tech Transportation Institute (VTI). Nearly 80 percent of crashes and 65 percent of near-crashes involved some form of driver inattention within three seconds before the event. Primary causes of driver inattention are distracting activities, such as cell phone use, and drowsiness.”

Within the past few years in nearly every state, new legislation has been introduced to address some facet of distracted or inattentive driving. Most of the bills are well intentioned. However, almost all focus on only one or a few in-vehicle behaviors, such as cell phone or text messaging system use, rather than addressing the main issue. Other bills, particularly those with age-based restrictions or prohibitions, are virtually unenforceable in the real world.

Several bills, however, specify that distracted or inattentive behavior that contributes to a crash would subject the vehicle operator to enhanced penalties, similar to aggravating circumstances such as operating a motor vehicle under the influence of alcohol or drugs. This approach is promising because enhanced penalties for violations resulting in injury or death to other roadway users holds violators more accountable for their actions. Note that specific restrictions or prohibitions are not required – any distracted or inattentive behavior that can be documented prior to a crash can be used as evidence.

Therefore, the AMA supports legislation that includes enhanced penalty options to be determined by the courts. Examples of penalties include the following, but are not limited to enhanced fines, operator's license suspension, points assessed on an operator's record, community service, and imprisonment. Additionally, the AMA supports the prominent placement of signage that notifies roadway users that the state provides specific sanctions for those convicted of moving violations while operating a motor vehicle in a distracted or inattentive manner. The inclusion of these sanctions depends on a state's current penalty structure of similar-magnitude offenses.

The AMA has adopted this position statement on distracted and inattentive motor vehicle operation because roadway users such as motorcyclists, bicyclists and pedestrians pay a disproportionately higher price for motor vehicle operator distraction and inattention.



All meeting minutes, are shared with each Chapter by the Secretary and should be shared with your members.





### Support H.R. 3385 - The Definition of a Motorcycle

Congressman Derrick Van Orden of Wisconsin has introduced a bill that directs the Secretary of Transportation to update the nearly 60-year-old federal definition of a motorcycle. In recent years, a new type of vehicle has entered our roadways, commonly referred to as an autocycle. These autocycles are classified as motorcycles at the federal level but have little resemblance to a motorcycle and the operational characteristics are vastly different.

The Motorcycle Riders Foundation believes this ambiguity about autocycles has created an unnecessary patchwork of rules and regulations regarding licensing, insurance, safety statistics, registration and training courses from state-to-state.

### Support S. 995 - The Choice in Automobile Retail Sales (CARS) Act of 2025


Senator Mike Crapo of Idaho has introduced the Choice in Automobile Retail Sales Act (CARS Act). This bill is similar to legislation that Congressman Tim Walberg introduced in the U.S. House of Representatives.

The focus of the bill is the protection of the internal combustion engine. It does this in two ways. First, the bill prohibits the use of authority under the Clean Air Act to issue regulations that mandate the use of any specific technology or regulations that limit the availability of new motor vehicles based on that vehicle's engine type. Second, the legislation requires the Environmental Protection Agency (EPA) to update any regulations that result in the limited availability of new vehicles based on that vehicle's engine.

The legislation would overturn a 2024 EPA rule, which currently would result in about 56% of new vehicles sold between 2030 and 2032 having to be electric.

Currently, the bill has 23 Senate cosponsors, but we need to improve that number! If you want to save the internal combustion engine, ask your Senator to cosponsor S. 995.

## Automated Driving Systems (AKA Autonomous Vehicles)



Late in 2020, the National Highway Traffic Safety Administration (NHTSA) announced a rule-making process for developing a “Framework for Automated Driving System (ADS) Safety.” As part of the process, public comments were solicited by NHTSA. In early February, the Motorcycle Riders Foundation (MRF) submitted a 6-page formal letter outlining our thoughts on the development, testing, and deployment of ADS.

Building on past submissions to both Congress and the U.S. Department of Transportation, the MRF laid out important priorities that NHTSA should consider. Some of the main topics the MRF highlights include the need to account for the unique attributes and characteristics of motorcycles, cyber security concerns, liability provisions, the role of individual states, the need for public transparency, threats to the protected communication spectrum and the challenges of regulations keeping pace with this technology.

While ADS has promising potential, the devil will be in the details. How this technology is developed, tested, and deployed will impact all Americans. The MRF will continue to fight to ensure motorcyclists are included in these discussions.

New York State's driver point system has been changed to increase penalties for repeat offenders and make it easier for insurance companies to access driving records. The new system includes:

## **More points for certain violations**

### **Many violations now have higher point values, including:**

- DWI: 11 points
- Racing: 5 points
- Failure to exercise due care: 5 points
- Leaving the scene of a crash: 3 points
- Passing a stopped school bus: 8 points
- Speeding in a work zone: 8 points
- Aggravated unlicensed operation: 11 points

### **Harsher penalties for repeat offenders**

- Drivers with multiple violations within 18 months face higher fines and possible license suspension

### **Mandatory Driver Responsibility Assessment (DRA)**

- Drivers with 6 or more points within 18 months must pay an annual DRA fee for three years

### **Online tracking and reporting**

- Law enforcement and insurance companies can more easily access driving records

The new system aims to keep drivers with multiple suspensions off the road.


